<b>Biography</b>	<p>Ivan Francis Champion was born in 1904 in Port Moresby, the son of administrator H W Champion. He was educated at The Southport School in Queensland, 1916-1922, and was appointed Patrol Officer in Papua in 1924. From December 1926 to January 1928 Champion accompanied Assistant Resident Magistrate Charles Henry Karius on the North-West Patrol, crossing New Guinea from the Fly to the Sepik. Champion later gave an account of this exploration in <i>Across New Guinea from the Fly to the Sepik</i>. In 1928 Champion was appointed Assistant Resident Magistrate, and was officer-in-charge at Kambisi from 1928 to 1929. He served at various posts until 1936, when he set out as leader of the Bamu-Purai Patrol. From 1937 to 1940 he was in charge of the exploration of the Southern Highlands. Champion held a number of posts as Resident Magistrate from 1940 to 1942. In 1942 he was appointed in the Australian Navy, and he became commanding officer of HMAS “Laurabada”. In 1945 Champion became District Officer, Western District. In 1946 he became Assistant Director of District Services and Native Affairs in the Papua New Guinea administration, and was Acting Director from 1949 to 1951. He was in charge of rescue work at the Mount Lamington volcano eruption in 1951. In 1952 he became Chief Commissioner of the Native Land Commission, and in 1963 became Senior Commissioner, Native Land Titles Commissioner. Champion retired in 1964.</p>
