Queensland, and is currently at Griffith University. He has lectured in both Australia and the USA. Siracusa is known for his research on United States foreign policy, American politics and Australian-American security relations. He has also written a book about Sallyanne Atkinson, the former Lord Mayor

of Brisbane.
