What it is

The Avery Brundage Collection is a North American source for the study of the modern Olympic movement. Materials comprise correspondence, minutes, reports, photographs, clippings, scrapbooks, artifacts, certificates, awards, honors, publications. Includes extensive files on the International Olympic Committee; National Olympic Committees; sports federations and organizations; the Amateur Athletic Union; U.S. Olympic Association and Committee; Olympic Games and regional games. Also includes files relating to Olympic Games in Melbourne, 1956.

How to find what you need

The Fryer Library holds a microfilm copy of parts of the Avery Brundage Collection. The original is held at the University of Illinois. Access to the microfilm copy is restricted to library users who submit an application form following these steps:

- Consult the index found in Brichford, Maynard J. Avery Brundage Collection 1908 1975. Schorndorff, Germany: K Hofmann, 1977 (see http://archives.library.illinois.edu/uasfa/2620037.pdf, or in print at Fryer Ref Z7511 .B75 1977) and make a note of which boxes you want to look at.
- 2. Match the box numbers to the microfilm reels listed below and note which reel(s) you need to look at.
- 3. Read the Policies and Regulations below.
- 4. Fill in the Application form below and hand it in at the Fryer Library Information Desk. Library staff will give you the reel(s) you need.
- 5. Return the microfilm reel to the desk when you have finished.

CONSULTATION

- 1. Persons shall make written application via the form below for permission to examine the collection. Permission, subject to any general restrictions on access, will be granted at the discretion of the Manager, Fryer Library to qualified and properly accredited persons whose purposes are acceptable.
- 2. Archival materials may be used only in the Fryer Library. Users are required to conform to the regulations governing handling and note-taking specified by the Manager, Fryer Library.

COPYING

- 3. Archives may not be copied by any process unless the applicant has given, by his/her signature on the attached application form, written assurance to the Manager, Fryer Library that no document or substantial portion of a document will be published or reproduced without the permission of the writer or his/her legal representative.
- 4. Permission to copy will normally be granted upon receipt of such assurance.

PUBLICATION

- 5. Permission to examine or to copy archival material does not convey the right to publish or to reproduce the material. Publication privileges may be secured only upon the authorisation of the holder of the copyright or the literary property rights. The owner of the literary rights may be the writer him/herself, his/her heirs or assigns, his/her legal representative or The University of Illinois at Urbana-Champaign. Responsibility for obtaining permission to publish rests with the researcher and his/her publishers. He/she understands that others may have legal rights prohibiting copying or quotation and, specifically, agrees to reimburse The University of Illinois for any loss occasioned to it because of the infringement of such rights. The University makes no representations to the literary rights, unless such rights have been given to the University.
- 6. Permission to publish will ordinarily be granted provided that: the applicant appears competent to deal with the materials in question (as attested by the applicant's references or by his position); the contemplated research project meets commonly-accepted standards of scholarship; prior publication rights to the material have not already been reserved for another scholar; and written permission for the specific use intended has been secured from the holder of the literary rights.
- 7. Where permission to publish is granted, the applicant agrees to indicate in the published work that the original manuscript is located in The University of Illinois Archives and to assume full and
