Series 1: Records of the Trades and Labor Council of Queensland

This series, contained in boxes 1-7, comprises material produced by the Trades and Labor Council or directly relating to TLC activities, mainly in the postwar period. The series is arranged into two sub-series: TLC material and material relating to political and industrial issues in which the TLC was involved (boxes 1-6), and material produced by or relating to the Australian Council of Trade Unions (ACTU), individual Australian trade unions and the international peak trade union bodies (box 7).

Box 1

Queensland Trades and Labor Council Records

Agendas, motions, minutes and reports of Queensland Trade Union Congresses for the years 1928, 1956, 1957, 1958 and 1960-1969.

Records relating to membership of TLC committees (1963), the ALP Queensland Central Executive (1967) and the Trade Union Social Committee (1959-1960), miscellaneous motions from unions to the TLC, and minutes of a TLC delegates' meeting held 23 February 1966. Includes lists of trade union representatives and organisations involved in the 1959 Congress, 1962 and 1963 Cavalcades and 1963 Brisbane Conference.

Box 2

Miscellaneous TLC correspondence, mostly from affiliated trade unions and other peak union bodies, including the Australian Railways' Union, the Building Workers' Industrial Union, the Federated Miscellaneous Workers' Union of Australia and the ACTU, 1964-1986. Includes inwards and outwards correspondence relating to the creation of the Alex Macdonald Memorial Library, 1969-1971

31 photographs of trade union officials, trade union members and Trades Hall, Brisbane, 1963-1975. People photographed include Alex Macdonald, Bob Hawke and Jack Egerton.

tour of the Reverend Norman Anderson, President of the Assembly of Peace, and copies of the Bulletin of the World Council of Peace from 1962 to 1966.

Conference papers, reports and other records of the Australian Congress for International Cooperation and Disarmament, Sydney, 1964. Includes conference papers and speeches by Rev A.M. Dickie, Hugh Hudson, Frank Boaten, Jean Richards, M.F. Lloyd-Prichard, Daija Ioka, B. Gale, Rev G. Dicker, Lucien Chavrot, Ichiro Moritaki and W.J. Latona.

Newspapers containing articles relating to peace and armament: *The Sydney Morning Herald* (7 Oct 1963), *The Australian Worker* (4 Nov 1964), *Scope* (26 Aug 1964?), *Tribune* (16 Sep 1964).

Bulletins, newspapers, flyers, reports, notes and correspondence relating to the war in Vietnam and the opposition to it from the peace movement and trade unions, 1964-1969. Includes copies of the *Vietnam Courier*, published in the Democratic Republic of Vietnam.

Box 4

Reports from trade union delegations to China, 1957 and 1959

Typed notes on Henry Boote's article, 'The Danger of Being Moderate'.

Records and ephemera relating to various political issues and campaigns, including bank nationalisation, labour in South Africa and Rhodesia, labour in Papua New Guinea, Indonesian independence, press censorship, Australian economic interests in Malaya, the Queensland Crimes Act, house prices, hire purchase, the pernicious impact of "trashy comics and books", and Aboriginal rights. Includes a copy of 'Reports and Resolutions Received by the 4th National Aboriginal Conference, The University of Queensland, 31 March – 2 April 1961', and a bound file of records relating to the National Television Congress 1963-1965, Brisbane Labour Day 1968-1969, and the death of Alex MacDonald.

Box 6

Series 2: Prewar Trade Union History

This series, contained in boxes 8 and 9, comprises miscellaneous documents and publications relating to pre-World War Two trade union history. They are arranged in three sub-series: Queensland trade union history, Australian trade union history, and international trade union history.
