<b>Date range</b>	2002 to 2008
<b>Biography</b>	Elaine Smith played a major role coordinating support for and communication with asylum seekers detained in Nauru by the Australian Government in the years following the 2001 <i>Tampa</i> incident. Beginning in 2002 she and her husband Geoff corresponded with hundreds of detainees and lobbied dozens of Australian politicians, government agencies and community organisations on their behalf. She was a member of Rural Australians for Refugees.
